Also, brought up was the bakery can be turned into a restaurant, which can be zoned as A-1 and present to Planning & Zoning Board for a conditional use permit, or amend the conditional use table. The last option discussed was to bring to the Planning and Zoning board to make it permitted to have commercial bakeries in every A-1 zone. Commissioners will discuss with County Counselor and Planning and Zoning Specialist. Presiding Commissioner Nelson stated that the first step will see if Commissioners can bring an amendment to the Planning and Zoning Board to permit bakeries to table of uses in A-1. Commissioner Burnham stated that Mr. Archdekin should not have to pay to go in front of the Planning and Zoning Board. Kristy Theas, Ryan Pummell, Jarrett Archdekin and Kyle Archdekin left the meeting at 9:45 am.

County Counselor Josh Bachman advised the Commissioners he spoke to Mark Woodbury about working on by laws for the Buchanan County Fairgrounds Board. Mark will be sending over an engagement letter.
