Mayor John Josendale, Police Chief Paul Luster and Interim City Manager Clint Thompson joined the meeting at 10:30. The Commissioner's met with Mayor Josendale, Police Chief Luster and Interim City Manager Thompson to discuss possible expansion of the current Law Enforcement Center or construction of a new facility. All agreed that the capacity to house more juvenile offenders is a pressing issue. Sheriff Bill Puett arrived at 10:50 a.m. The current facility is nearing 40 years old and has issues with piping, HVAC, safety and access. Going forward the group needs to prioritize juvenile, mental health and either upgrading the current facility or focusing on a new building.
